## I. PROJECT BACKGROUND AND SCOPE OF WORK

# **GAIN AND CARE**

The Global Alliance for Improved Nutrition (GAIN) is a Swiss-based foundation established in 2002 at the UN to combat malnutrition by transforming food systems to ensure access to nutritious food for all. GAIN collaborates with governments, businesses, and civil society, employing tailored approaches to address food insecurity, particularly for vulnerable populations. With a mission to reach one billion people, GAIN supports various initiatives, including food fortification and agricultural improvements, while leveraging partnerships to provide technical and financial assistance. Their efforts have impacted an estimated 667 million people globally, focusing on sustainable solutions that enhance nutrition across diverse contexts.

CARE International is a global NGO operating in 100 countries, dedicated to alleviating poverty and promoting equality through local solutions. In Kenya since 1968, CARE's programs encompass disaster response, food security, climate change adaptation, and women's empowerment. The organization emphasizes community-driven initiatives that address health, education, and economic opportunities for marginalized groups. By fostering local partnerships and implementing comprehensive strategies, CARE aims to improve the well-being of individuals and communities, particularly focusing on women and children as key agents of change in overcoming challenges related to poverty and inequality

## CASCADE PROJECT

CARE Kenya and GAIN are implementing **CAtalyzing Strengthened policy aCtion for heAlthy Diets and resilience (CASCADE)** project, whose goal is to improve food security and contribute to the reduction of malnutrition of at least five million women of reproductive age and children under fifteen years in Benin, Nigeria, Uganda, Kenya, Ethiopia and Mozambique. The programme has two strategic objectives: it aims to increase access to and consumption of healthy diets, as well as increasing the resilience of households to economic and climate change-related shocks across the six countries, with a focus on women of reproductive age and children.

CASCADE aims to galvanize government, business, and communities around 5 domains: The CASCADE project began implementation in Kenya in June 2022 with an aim to improve food security and contribute to the reduction of malnutrition of women of reproductive age and children under fifteen years. The project has two strategic objectives which are: (1) Increased access to and consumption of healthy diets and (2) Increased Household Resilience to economic & climate-related shocks. The project is implemented through 5 domains including: (i) Policy change and accountability to advocate for the improved implementation of nutrition-related policies, Strengthen the capacities of nutrition-related policy makers and delivery systems, and Create opportunities for dialogue to improve the quality, efficiency and accountability of policies and services, (ii) Re-engineering markets and mobilizing private sector to engaging private service providers to offer accessible and affordable products and services that promote healthy diets and resilience to shocks and stresses – also promote public-private partnerships (PPPs) in agriculture, (iii) Transforming cultural norms and practices by shifting harmful social and gender norms that impact nutrition practices, strengthen the advocacy capacities of women's CBOs, CSOs and women's collectives, and Strengthen the capacities of nutrition-related service providers and systems (iv) Empowered women - taking a Gender Transformative Approach through increasing women's access to and control over resources, Strengthening the knowledge and skills of women small-scale producers, and increasing households' knowledge, attitudes and practices in nutrition and WASH and (v) Strengthened coordination through data systemization and policy learning by collecting, using & disseminating data for more impact, and connect relevant nutrition-related programmes, networks and actors.

In Kenya, CASCADE project focuses on Nakuru, Nyandarua and Nairobi counties with cross cutting





effect at national levels. Aligning with GAIN's A1 program (Vegetable for All project) areas at national levels and in the targeted Counties, CASCADE also builds on successful projects in Nyandarua by CARE which have successfully implemented Farmers' Field and Business Schools (FFBSs) that integrated gender-transformative interventions. Apart from sustaining the gains made, the CASCADE project targets to galvanize government commitments towards policy change and accountability and respond to GAIN's goal towards strengthening food systems in Kenya and supporting stakeholders' actions at county and national levels.

## 1. BACKGROUND

Kenya faces the triple burden of malnutrition: undernutrition, micronutrient deficiencies, and overweight/obesity. Nationally, 18 percent of children under five years are stunted, 10 percent are underweight, and 3 percent are overweight or obese. Additionally, 42 percent of women experience iron deficiency anemia during pregnancy (KDHS, 2022). The economic cost of malnutrition is substantial, with the country estimated to have lost Ksh. 373.9 billion, equivalent to 6.9 percent of the Gross Domestic Product (GDP), due to malnutrition-related health, education, and productivity impacts (Cost of Hunger Africa, 2019).

These statistics highlight that malnutrition is a complex, multifaceted challenge that requires innovative, evidence-based strategies and strong political commitment. Addressing malnutrition effectively is critical to Kenya's progress in achieving global targets, including the Sustainable Development Goals (SDGs) and the World Health Assembly (WHA) targets.

This consultancy will focus on **Domain1,2,3,4,5**, which emphasizes D1, Government bodies' nutrition-related policy actions are better coordinated and more effectively implemented; D2- Private service providers enhance the effective implementation of nutrition-related policy actions: D3, Community structures facilitate more responsive & equitable nutrition-relevant services; D4 Women demonstrate agency to make decisions about healthy diets in the households and D5, strengthened coordination and linkages among food system actors and processes.. By improving the collection and analysis of outcome data, the project fosters accountability and ensures that stakeholders, including policymakers and donors, have access to valuable insights into the effectiveness, efficiency, scalability, and impact of CASCADE interventions.

Through this Request for Proposal (RFP), the CASCADE project seeks a qualified service provider to conduct **Outcome Harvesting** to capture intermediate and immediate project outcomes and assess their contribution to the project's overall impact. The selected service provider will be engaged for a period of **three (3) months, from April to June 2025**.

# 2. PURPOSE OF THE CONSULTANCY

The purpose of this consultancy is to conduct Outcome Harvesting systematically identify, document, and analyze the changes influenced by the CASCADE project in policy influence and food system strengthening across Nairobi, Nakuru, and Nyandarua counties. The consultancy aims to assess how CASCADE interventions have contributed to improving access to healthier diets, enhancing resilience to price and climate shocks, and promoting gender-responsive nutrition programming.

By applying the Outcome Harvesting methodology, the consultant will capture intermediate and immediate project outcomes, evaluate their significance, and provide evidence-based insights to





inform project learning, adaptation, and decision-making. The findings will support policy advocacy, private sector engagement, and data-driven improvements in food systems to ensure sustainable nutrition outcomes.

This process will enhance accountability and impact measurement, ensuring that stakeholders—including policymakers, donors, and implementing partners—can effectively track progress, scale up successful interventions, and refine strategies to maximize CASCADE's contribution to Kenya's nutrition and food security goals.

This is being achieved through five intermediate outcomes namely: Community structures are drivers of change that positively support improved implementation of nutrition-related policies and practices; Empowered women have increased knowledge, skills and resources to produce, acquire, prepare and consume healthy diets and Strengthened coordination and linkages among food system actors and processes

Therefore, through this RFP, GAIN seeks to engage a qualified service provider for a period of three months (April 2025 – June 2025) to execute evidence based outcome harvesting of Domain 1, 2, 3 4,5 which looks at: D1, Government bodies' nutrition-related policy actions are better coordinated and more effectively implemented; D2- Private service providers enhance the effective implementation of nutrition-related policy actions: D3, Community structures facilitate more responsive & equitable nutrition-relevant services; D4 Women demonstrate agency to make decisions about healthy diets in the households; D5, strengthened coordination and linkages among food system actors and processes. All these domains will be assessed in terms of showcasing their outcome contributions and linkages to healthier diets and their resilience to price and climate change-related shocks. These intermediate outcomes are derived from immediate outcomes which are to be achieved from the activity results. These immediate outcomes under review include.

# **Government Awareness and Capacity:**

- County governments demonstrate a clear understanding of CNAP (County Nutrition Action Plan), ASTGS (Agricultural Sector Transformation and Growth Strategy), and WEE (Women's Economic Empowerment) strategies through assessments or surveys.
- Functional county multisectoral committees actively coordinate and implement nutritionrelated policies, measured by meeting frequency, joint activities, and collaborative reports.
- Increased allocation of county resources to nutrition-related activities, evidenced by budget analysis and expenditure tracking.
- Implementation of county-level climate-related shock response plans that integrate nutritionsensitive interventions, as demonstrated by documented plans and implementation reports.
- Increased effectiveness of social protection measures and their impact on consumption of healthier diets and resilience.
- Measurable increase in enrollment of beneficiaries in enhanced single registry and e-voucher systems, particularly among farmers, tracked through registry data.

# **Private Sector Engagement:**

 Increased compliance rates among private sector actors with food and nutrition-related policies and standards, assessed through audits and certifications (private sector labs and





food safety experts which support the government in regulating food production standards), compliance in SBN, School meals, millers)

- Documented collaborations and partnerships between private sector providers and government actors to enhance involvement in nutrition strategies.
- Functional SUN Business Network in delivering services and input to reach the last mile /farmers in terms of fortified foods, distribution through school feeding, THEN this will lead to increased access to nutrients
- Private service providers support the implementation of agricultural/nutrition policy by increasing small-holder farmers' access to productive assets (Finance, cash transfers, agriculture insurance, subsidized inputs)

#### Stakeholder Awareness and Data Utilization:

- Percentage increase in key stakeholders' self-reported awareness and understanding of available data and knowledge products
- key stakeholders reporting increased awareness and application of project achievements in nutrition programs in their respective activities, assessed through surveys and feedback mechanisms
- Accessing the data for impact through SUN networks (CSA, SBN), government multisectoral bodies and technical committees

## 2.1. OBJECTIVES

The Outcome Harvesting consultancy for the CASCADE project will focus on identifying, analyzing, and documenting the impact of the project's interventions in policy influence and food system strengthening across Nairobi, Nakuru, and Nyandarua counties. The specific objectives of this assignment are:

- Assess CASCADE's impact on policy changes, commitments, and actions at national and county levels, focusing on improvements in implementation, accountability, and stakeholder engagement.
- 2. Analyze improvements in food safety, market access, supply chains, and affordability of nutritious foods, while identifying barriers and opportunities to enhance resilience to price fluctuations and climate shocks.
- 3. Assess how CASCADE has promoted gender equality in access to nutrition resources and services, including shifts in social norms, women's empowerment, and integrating gender into policy and interventions.
- 4. Document progress made towards performance of immediate and intermediate outcomes as indicated in the result framework and synthesize impact, lessons learned, and recommendations for future improvements.
- 5. Assess the quality and use of outcome data to track progress, strengthen reporting and learning, and provide recommendations for improving data collection and application in decision-making.





## **METHODOLOGY AND DELIVERABLES**

## **METHODOLOGY**

The consultant will use a mixed methodology that shall incorporate qualitative and quantitative approaches as well as the desk review of the project's existing information such as the reports on each of the outputs highlighted in the results framework. The service provider will need to attend relevant workshops organized by the project team, including the PSP, community-based organizations, and policy-related workshops. These workshops will bring together MSPs to share important information and help plan field activities. By engaging stakeholders in discussions about what has changed, outcome harvesting shall capture both intended and unintended outcomes, providing a comprehensive understanding of how interventions have contributed to these changes. This participatory approach shall contribute to the credibility of findings and promote` accountability among stakeholders. Lastly, the provider will collaborate with project staff in meetings to build consensus at different stages of the assignment.

Analysis of outcome harvesting shall emphasize understanding contributions rather than attributing outcomes solely to specific interventions, allowing for a richer analysis of the factors influencing change. This shall require training of the enumerators to internalize this retrospective approach.

It is envisaged that outcome harvesting shall provide valuable insights that can enhance program design and implementation in future initiatives as well as real-time decision-making and strategy adjustments based on insights gathered throughout the project's lifecycle.

The final budget amount will have to be approved by GAIN prior to starting the assignment.
